The head leaders of **EUROMON PLV** company, commit to apply a Quality, Environment and Custody Chain Policy for forest and tree products, implemented within a framework of Integrated Quality, Environment and Custody Chain Management System in accordance with the ISO 9001:2015, ISO 14001:2015 and FSC® standards that involves all people and areas of the organization. The scope of our IMS is "Design and manufacturing management (assembling and packaging) of permanent displays and eco-exhibitors with certified wood at the point of sale", with the mission of offering a wide variety and models of: floor, counter, luminous, promotionals, interactives, etc. and in all kinds of materials: metal, plastic, glass, wood, certified wood, etc. to achieve constant improvement and keep progressing in terms of technology level. Our IMS is applicable at our facilities in Molins de Rei (Calle de Miquel Torelló i Pagès, 28, 08750 Molins de Rei, Barcelona).

**EUROMON PLV** perceives the Integrated Quality, Environment and Custody Chain FSC® System as a way of organizing the performance of the company, starting from basic pillars such as the quality of its products, the satisfaction of the interested parties, besides managing the environmental aspects, emergencies, risks, legal requirements and the continuous improvement of the effectiveness of the System, and furthermore the origin of the forest and tree products used for the ECO line products. For this, the IMS of **EUROMON PLV** is based on:

- Quality and its improvement are the responsibility of all **EUROMON PLV** members, starting from the top. It is obtained by planning, executing, reviewing and improving the Integrated Management System, keeping in mind at all times our internal and external context.
- The guidelines of the Integrated Quality, Environment and Custody Chain System are reflected in the Integrated System Manual, a document that includes the company's entire strategy for the IMS.
- Our activity is oriented towards the satisfaction of all our customers (and stakeholders), through the commitment to meet their needs and requirements.
- The strategic guideline of the organization is the commitment to accomplish the legislation and applicable regulations in our activities, in terms of quality, environment and custody chain, as well as ensuring safety prevention and health of our workers, in addition to other commitments that may be established in this regard, striving to continuously improve our environmental performance.

- Provide accurate and verifiable information that forest and tree products used in our ECO line are recycled and come as well from sustainably managed forests, FSC® certified and FSC® controlled sources:
- Our commitment to contribute to sustainable resources management and a firm compromise with the United Nations Sustainable Development Goals (SDGs).
- The purpose of communicating the origin of forest and tree products is to encourage the supply and demand for products from sustainable managed forests, thereby promoting continuous improvement in the management of the world's forests driven by markets.
- Promote efficient use of available natural resources and continuously intensify our environmental management to obtain improvements in the company's global performance, focused on life cycle analysis, environmental protection and pollution prevention.
- Identify and control the environmental aspects and the risks of the organization, in such a way that we establish a preventive approach.
- The annual publication of Quality, Environment and custody chain objectives, set by the Direction managers, and making this objectives public to all of our staff members. The objectives must be well known and assumed in such a way that the daily tasks lead to their achievement in the shortest possible time.
- Develope and sensitize organization's staff regarding the quality of our products, the environmental performance
  and the preservation and control of the custody chain, besides providing the necessary resources for the correct
  functioning of the integrated management system.
